

Annual Dues and Building Usage Fees Notice

Your membership notice is included with this issue of PawPrints. All dues and building usage fees (and other outstanding fees, such as Trophy pledges, and class fees) must be paid on or before January 1, 2012 to vote at the January meeting. Memberships will be considered lapsed if dues, building usage fees, and outstanding fees are NOT paid by January 31, 2012, and you will need to reapply per new member requirements.

Please **check the correct category when returning your dues / building usage fees notice**. Consult your membership book (the By-Laws) as to the type of membership and year you joined QCDTC. If you have questions about your membership, please contact membership chairs Robin Niedenthal or Elaine Waxler.

_____ **Regular Membership:** Total annual fees are \$50 (\$30 for dues and \$20 for building usage fees) for persons 18 years and older. This membership allows only paying members to train on the floor, take classes at reduced rates and vote. Other family members who wish to train must apply for membership.

_____ **Combined Membership:** Total annual fees are \$75 (\$45 for dues and \$30 for building usage) This membership is for two members of the same household who are regular members. See note below for life members.

_____ **Junior Membership** is \$15 per year for those at least 12 years old, but under 18. To change to regular membership at age 18 you need Board approval. Junior members enjoy all club privileges except the right to vote and hold office.

_____ **Associate Membership:** Total annual fees are \$50 (\$30 dues/\$20 building usage fee) for 18 years of age and older. Associate members shall enjoy all club privileges except the right to vote and hold office. This is the level at which new members now join the club. After one year, Associate Members may apply to become Regular Members (give to Membership Chairman, to be voted on).

_____ **Inactive Membership (formerly Associate)** is \$15 per year for 18 years of age and older. May not vote, hold office, no reduced rates or special training privileges. Board approval is required to change membership from Inactive back to Regular.

_____ **Honorary Membership** - Honorary membership is appointed by the Board of Directors or the club membership. Members shall enjoy all club privileges except the right to vote and hold office. Dues are waived for Honorary members. Honorary members who exercise the right to train in the building are responsible for the \$20 annual building usage fee.

_____ **Senior Membership:** Total annual fees are \$35 (\$15 for dues and \$20 for building usage) This membership applies to individuals who have been with the Club at least five (5) years and are at least fifty-five (55) years of age, but less than sixty-five (65) years of age.

_____ **Lifetime Membership:** Total annual fees are \$20 individual, \$30 combined (building usage fees only - dues are waived for a lifetime member). Your age, plus the number of years you have been a club member must add up to at least 75 years. You must make your request in writing to the Board to become a lifetime member. This is done just one time, not every year. **But all lifetime members must return dues notice.**

_____ **I am dropping my membership at this time.** To rejoin at a later date, you will have to apply as a new member.
