AGREEMENT

QCDTC's current COVID-19 Health and Safety Recommendations will be followed.

Further, the owner/trainee hereby agrees that he will not bring, or permit to be brought the dog named above, or any other dog under his control, to any class of the Queen City Dog Training Club, Inc. (QCDTC) or to or upon the premise where such class is being held while such dog has, to the owner's knowledge, distemper, parvovirus, or other communicable disease or parasites, or shall be exposed to any disease, or shall come in contact with or be kenneled or kept upon premises where there has been any dog which was exposed to any disease within a period of 30 days prior to the day of such contact, kenneling, or keeping, then the owner/trainee agrees that he will not bring, permit or cause to be brought such dog to such class, or upon such premises, until 30 days after such dog has fully recovered from such disease, or until 30 days after exposure, contact, or keeping.

The owner/trainee must bring a crate into the building or crate the dog in the vehicle for this class. All dogs must enter the building under control on a leash and collar; the use of a harness is not appropriate for entering the building. All dogs must remain in their crate or in their owner's/trainee's vehicle unless it is their team's turn to work in the class.

The owner/trainee further agrees that he will not bring to any class a dog that is known to be vicious and further agrees to adhere to the floor rules of QCDTC. QCDTC may, with cause, refuse to admit any dog to any of its classes or premises, and QCDTC may, with cause, dismiss any dog from class or from the premises. In consideration of the premises and of the opportunity to attend classes of QCDTC, the owner/trainee agrees to hold QCDTC, its officers, directors, members, agents and employees and each of them harmless from any and all claims arising out of or in any way connected directly or indirectly with or caused by: (1) any biting or other action by or on the part of any dog owned by or under the control of the owner/trainee, his agents, or employees while such dog is on the premises or grounds owned or leased by or under control of said club; or at or near any entrance thereto; or in attending the classes of Club, or (2) the disappearance, loss, theft, or death of or damage or injury to any dog owned or under the control of the owner/trainee, his agents, or employees, whether or not caused, in whole or in part, by negligence or carelessness of said Club, or of its officers, directors, members, agents, or employees, or any of them; and the owner/trainer hereby agrees to assume responsibility and liability for any claims.

CANCELLATIONS AND REFUNDS: No refunds will be given for cancellations made less than 14 days prior to the beginning of class. Refunds will be given for cancellations made more than 14 days before the scheduled beginning of class. However, a \$15.00 fee will be deducted from the refund.
